hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Upgrading part of Hopton Footpath 8 to Public Bridleway with runs from Point A on the application map (OSGR TL 98860 78828) the western termination of the application route, to Point B (OSGR TL 99171 78782) the junction of Hopton Footpaths 8 and 9 and Bury Road.
- b) Upgrading Hopton Footpath 9 to Public Bridleway with runs from Point B on the application map (OSGR TL 99171 78828)) the junction of Hopton Footpaths 8 and 9 and Bury Road, to Point C (OSGR TL 99597 78622) the junction of Hopton Footpath 9 and Hopton BOAT 12.

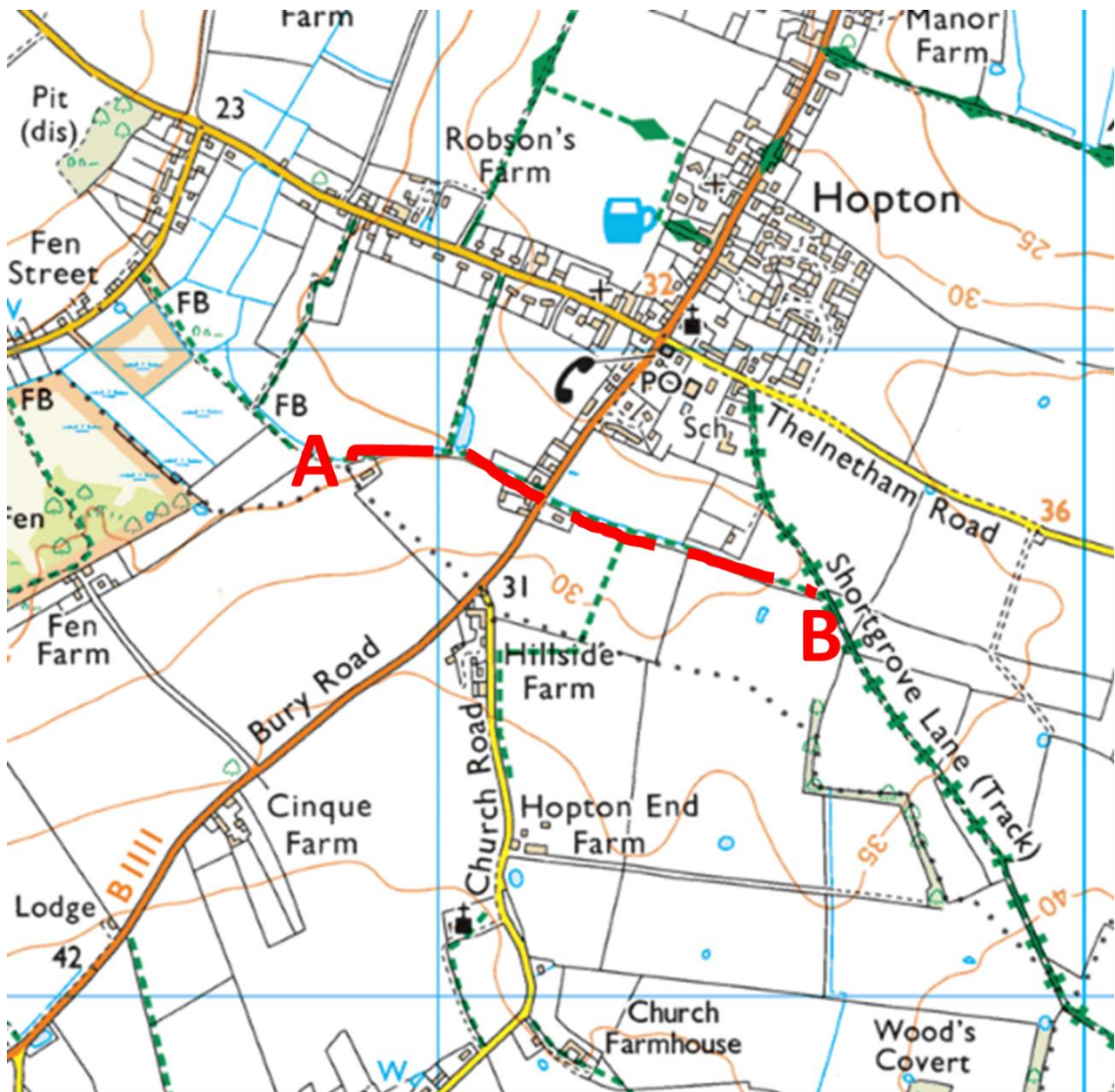
