hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Upgrading Wickham Market Footpath 28 to Public Bridleway which runs from Point A on the application map (OSGR TM 30704 55615) the junction of the application route, Wickham Market Footpath 28 (Sandy Lane) and Mill Lane, to Point B (OSGR TM 30767 55360) the junction of Wickham Market Footpath 28 (Sandy Lane) and Pettistree Footpath 6 (Green Lane).
- b) Upgrading Pettistree Footpath 6 to Public Bridleway which runs from Point B on the application map (OSGR TM 30767 55360) the junction of Wickham Market Footpath 28 (Sandy Lane) and Pettistree Footpath 6 (Green Lane), to Point C (OSGR TM 30594 55139) the junction of Pettistree Footpath 6 (Green Lane) and Chapel Lane.

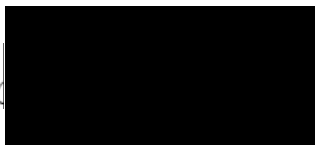
