I, Charlotte Ditchburn, for and on behalf of the British Horse Society, of Abbey Park, Stareton, Kenilworth, Warwickshire. CV8 2XZ.

hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR TL 94478 60893) the eastern termination of the application route, to Point B (OSGR TL 94422 60893) the junction of the application route and Hessemett Footpath 4.
- b) Upgrading part of Hessemett Footpath 4 to Public Bridleway which runs from Point B on the application map (OSGR TL 94422 60893) the junction of the application route and Hessemett Footpath 4, to Point D (OSGR TL 93821 60933) the western termination of Hessemett Footpath 4 at its junction with Hubbard's Lane.
- c) Adding the Public Bridleway which runs from Point D on the application map (TL93821 60933), the western termination of Hessemett Footpath 4 at its junction with Hubbard's Lane, to Point E (OSGR 94178 60437).
- d) Adding the Public Bridleway which runs from Point E on the application map (TL 94178 60437), to Point C (TL 94231 60917) the junction of the application route and Hessemett Footpath 4.
- e) Adding the Public Bridleway which runs from Point E on the application map (TL 94178 60437) to Point F (TL 94412 60216) the eastern termination of the application route.

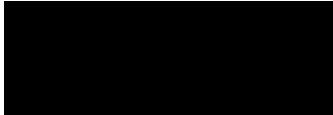

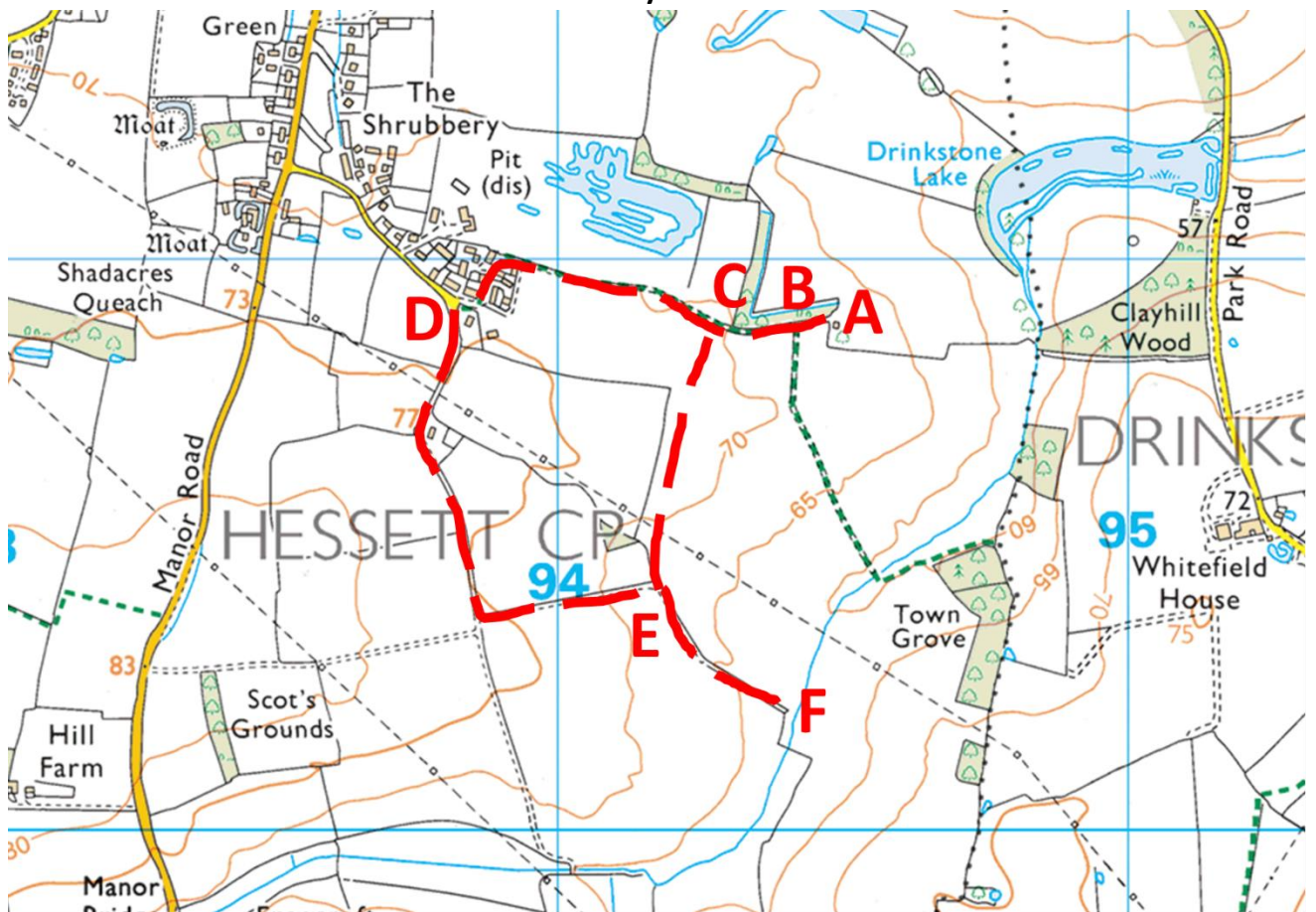
