hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Upgrading Ingham Public Footpath 8 to Byway Open to All Traffic which runs from Point A on the application map (OSGR TL 85543 74188) the junction of Ingham Footpath 8 and Culford Byway Open to All Traffic 14, to Point B (OSGR TL 85011 73397) the junction of Ingham Footpath 8 and Culford Footpath 3.
- b) Adding the Byway Open to All Traffic which runs from Point B on the application map (OSGR TL 85011 73397) the junction of Ingham Footpath 8 and Culford Footpath 3, to Point C (OSGR TL 84611 72743) the southern end of the application route.
- c) Upgrading Culford Footpath 3 to Byway Open to All Traffic which runs from Point B on the application map (OSGR 85011 73397) the junction of Ingham Footpath 8 and Culford Footpath 3, to Point D (OSGR TL 84423 73764) the junction of Culford Footpath 3 and Culford Byway Open to All Traffic 10.

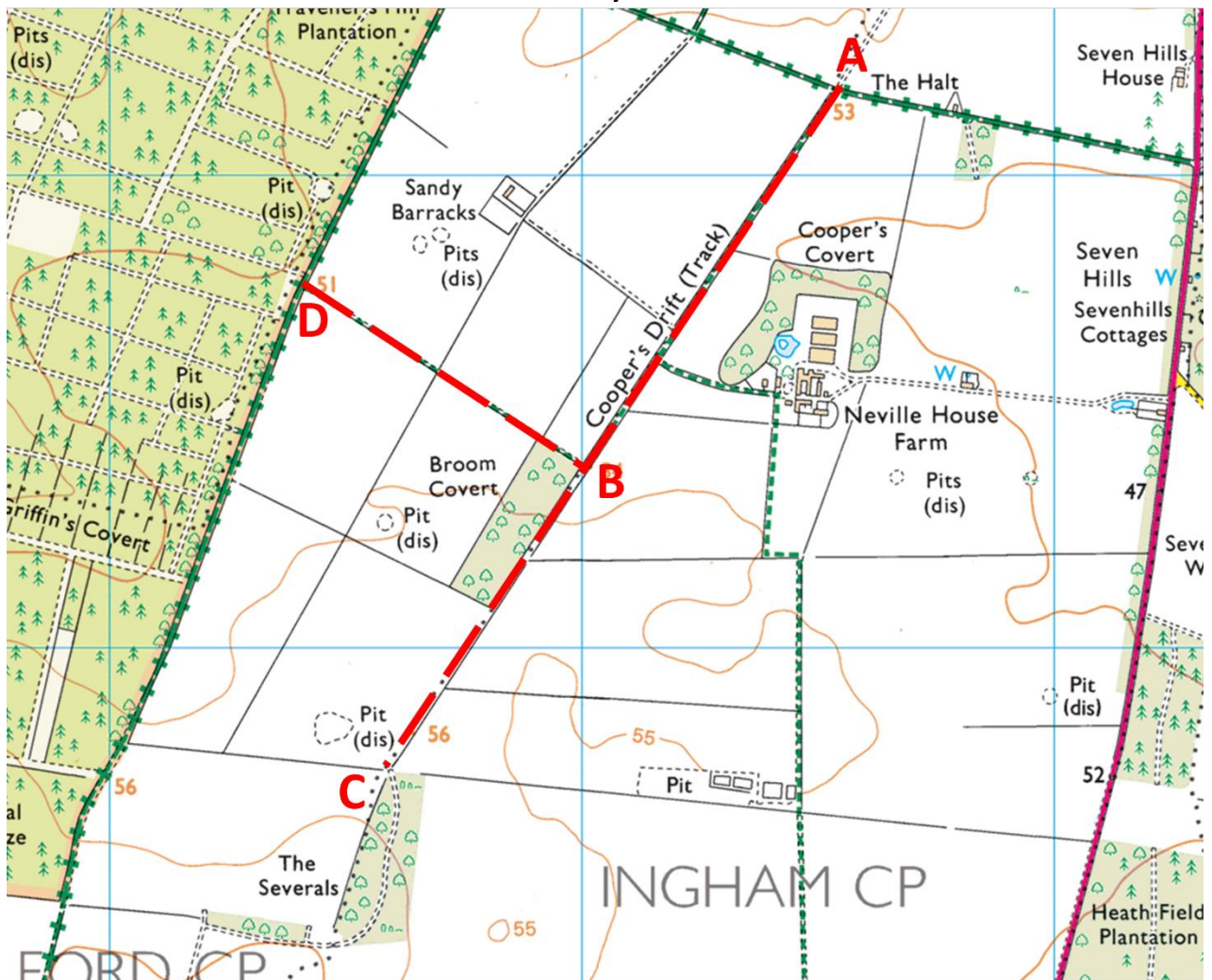
