hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR TL 84189 52627) the southern termination of the application route at junction with Hartest Byway 20 and Chadacre Road, to Point B (OSGR TL 84202 52672) the junction of the application route and Hartest Footpath 6.
- b) Upgrading part of Hartest Footpath 6 to Public Bridleway which runs from Point B on the application map (OSGR TL 844202 52672) the junction of the application route and Hartest Footpath 6, to Point C (OSGR TL 84586 52894) the northern termination of the application route at the junction of Hartest Footpath 6 and Hartest bridleway 6.

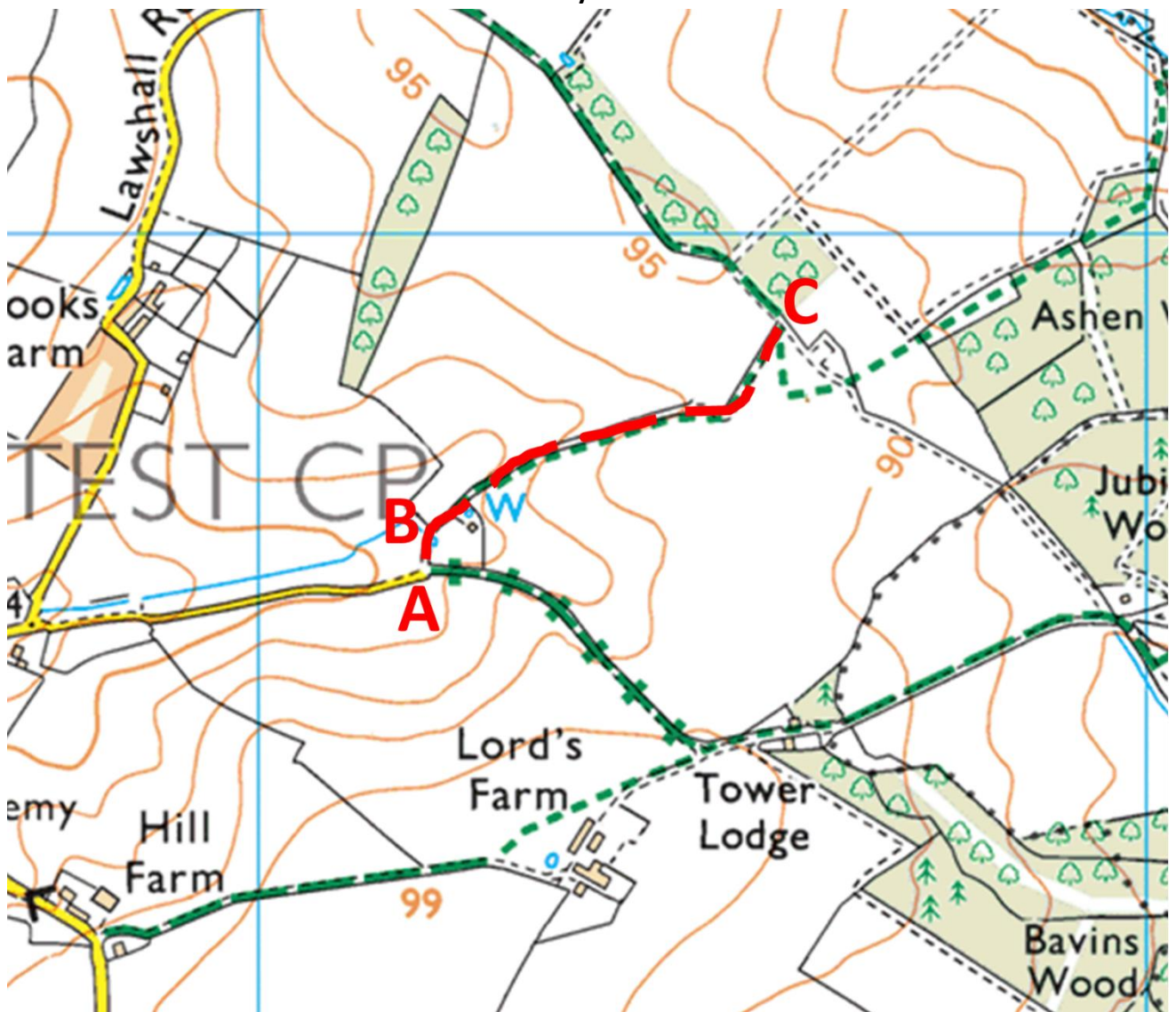
