hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR TL 78714 55831) the junction of the application route, Depden Footpath 7 and Gatesburys Lane, to Point B (OSGR TL 78803 55779) the junction of the application route and Rede Footpath 1.
- b) Upgrading Rede Footpath 1 to Public Bridleway from Point B on the application map (OSGR TL 78803 55779) the junction of the application route and Rede Footpath 1, to Point C (OSGR TL 79073 55888) the junction of Rede Footpath 1 and Rede Bridleway 3.

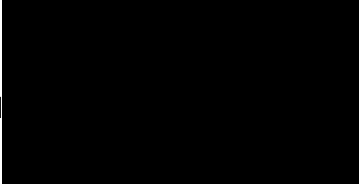

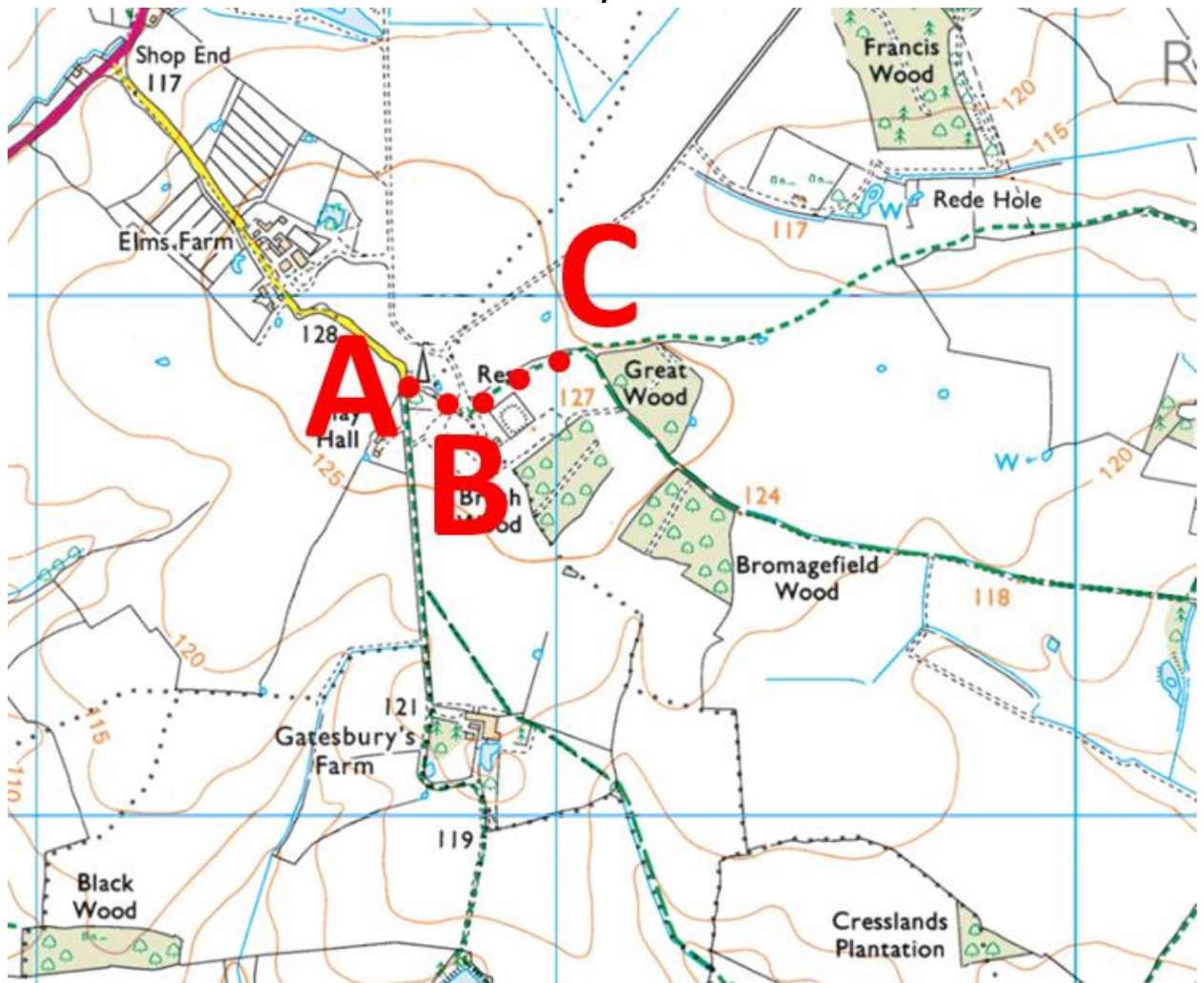
